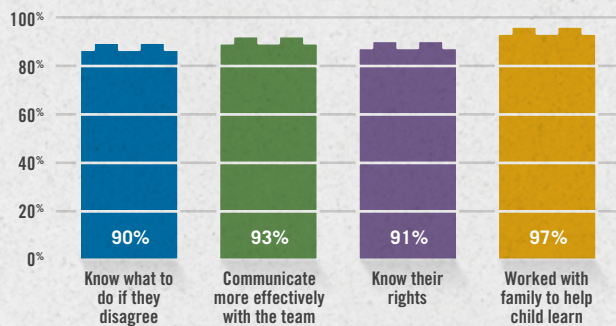

The Pennsylvania Office of Child Development and Early Learning provides families with access to high-quality services to prepare children for school and life success.

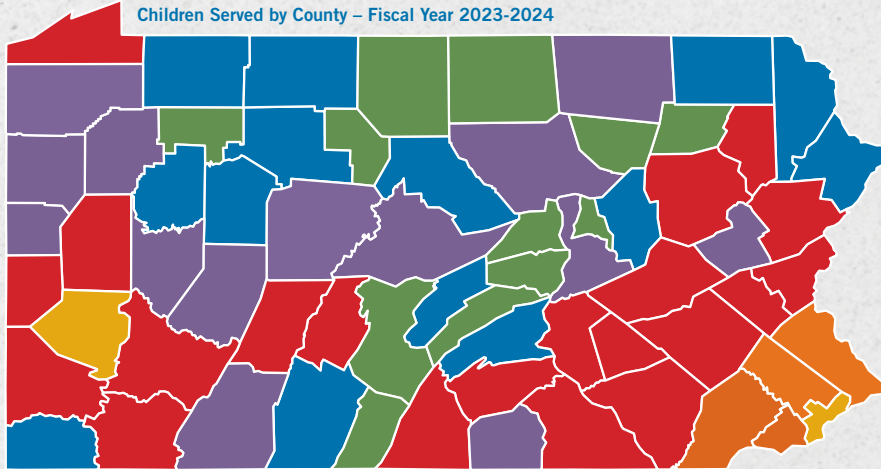

Early Intervention in Pennsylvania

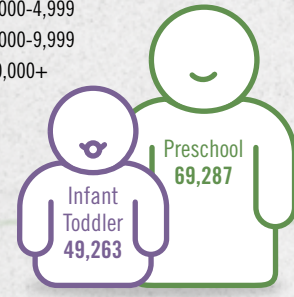

Children Served by County



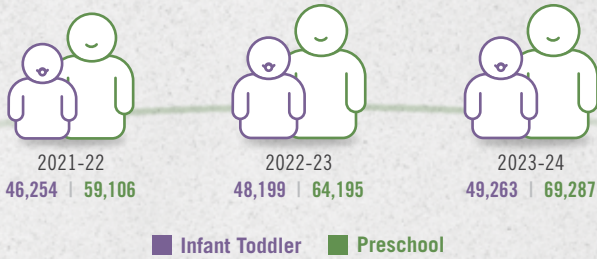
Children Served in PA: (Ranges)

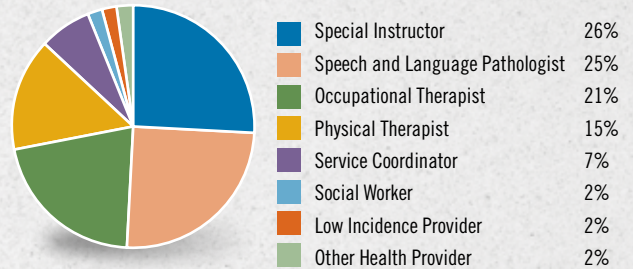

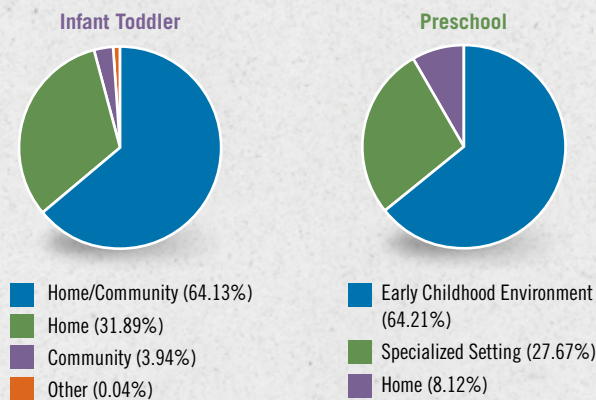
Number of Children Served



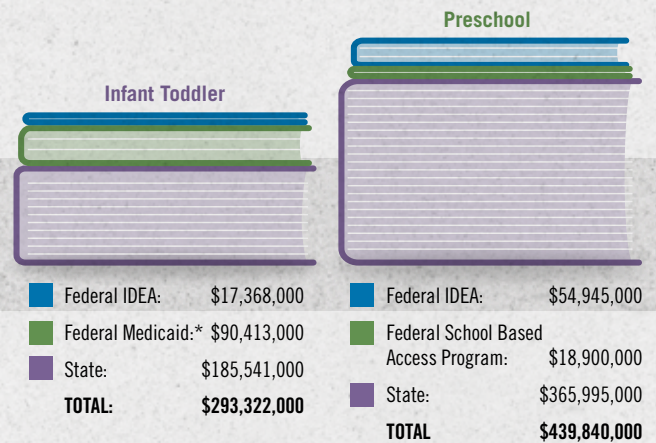
Infant Toddler Early Intervention Workforce
